Opening permission has been accorded for classes I to VII Classes (EM) from 2013-14 to St. Ann's EM School, Bakkavanipalem, Madhurawada Post, Visakhapatnam vide reference 1st cited.

The Correspondent, St. Ann's EM School, Bakkavanipalem, Madhurawada Post, Visakhapatnam has submitted documents for provisional temporary recognition for classes I to VII English Medium for the years from 2013-14 to 2017-18 in the reference 2nd cited.

The Mandal Educational Officer, Pendurthi has verified the application for provisional recognition with reference to the conditions laid down in the previous orders and G.O.Ms.No 1 Edn Dt 01.01.1994 and submitted a report in his letter 3rd cited. After careful examination of the references cited, the District Educational Officer, Visakhapatnam is hereby accorded provisional recognition for a period of 5 years commencing from the academic year from 2013-14 to 2017-18 for classes I to VII (EM) subject to fulfillment of following conditions to St. Ann's EM School, Bakkavanipalem, Madhurawada Post, Visakhapatnam.

- 1) That the Society shall abide by the instructions / rules and regulations made by the Govt. or authorized Officer from time to time.
- 2) That the Educational Institution shall serve the needs of the locality more particularly.
- 3) That the institution shall adopt the curriculum and syllabus prescribed by the Govt. from time to time.
- 4) That the school timings, vacations and Mid-term holidays shall be as prescribed by Govt. from time to time.
- 5) That the qualified staff within the age limits prescribed by the Govt. for Govt. employees shall be appointed as per the staff pattern.
- 6) That the results of institutions shall be satisfactorily every year.
- 7) That the records/ accounts shall be furnished to the Inspecting Officer every year by 30th September at least.
- 8) That the list of Governing Body shall be furnished to the District Educational Officer, Visakhapatnam every year.
- 9) That the pay structure/fee structure fixed by the Governing body shall be got approved by the Dist. Educational Officer every year.
- 10) That all the conditions prescribed in the G.Os and other orders which are not specified in this order shall be complied with.
- 11) That the school shall not be closed without giving notice both to the parents/ Dist. Ednl Officer and competent authority at least six months before.
- 12) That the school shall be closed or permitted to be closed only from the date on which summer vacation is declared.
- 13) That the society shall submit proposals for renewal of recognition sufficiently in advance i.e. at least six months prior to the date of expiry of present recognition.
- 14) The school shall follow the traffic and safety guidelines indicted by the traffic police and fire service dept.
- 15) The Parent teachers associations meeting shall be conducted to sensitize the parents on the safety of the children
- 16) The school should have first aid kit and the teachers should be trained in first aid.
- 17) The Management is informed that no thatched roof accommodation is allowed to run the school.
- 18) That the society should provide fire safety measures in the school.
- 19) Wide corridor should provide since the 6 feet corridor is not sufficient.
- 20) Sufficient Place should be provided for conducting daily school Assembly, National Festivals.
- 21) The Management is hereby informed that the recognition is being given purely on a temporary basis and subject to the report of State Level Inspection and Vigilance Committee on fulfillment of all the prerequisite conditions under A.P. Education Act, 1982 and if later found that the school has not fulfilled any pre-requisites as stipulated, the recognition now being given is liable to be withdrawn at once.

1. That the society shall abide to the rules and regulations made in the Government order 1st cited above.
2. That the society shall provide the necessary amenities like accommodation, Sanitary facilities, Drinking Water facilities, Furniture, Library, Laboratory Equipment, Play Field required staff as per the staff pattern and other facilities are necessary, before approaching the competent authority.
3. That the society shall apply for recognition by 31st March at the latest duly fulfilling the condition for the commencement of recognition from the coming academic year..
4. That the permission accorded is valid for 12 months only from the date of its issue. Permission shall lapse automatically if agency fails to get recognition for the school for what so ever reason within this period..
5. That this permission does not confer any right on the society for claiming recognition.
6. That the permission is accorded to CONGREGATION OF THE CATECHIST SISTERS OF ST.ANN" Regd.No. 132/1963, Dated: 30.09.1963 and no other society or body can open a school on their behalf of.
7. The permission is accorded to open / upgraded in the locality indicated above and there shall not be change in the premises or locality.
8. The society shall provide the necessary material even if it costs more than the deposit amount
9. Proper and adequate parking area for vehicles shall be provided transporting the children to and for the school.
10. Proper and adequate sanitation facility shall be provided for students especially for girl students.
11. Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.
12. The school shall follow the traffic and safety guidelines indicated by the police and fire services departments.
13. The parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the children.
14. The school shall have first aid kit and the teachers shall be trained in first aid.
15. The management should fulfill all the conditions as per G.O.Ms.No. 41 Edn, Dt. 11.5.06 at the time of applying for Provisional Recognition.
16. The management is hereby informed that, the permission is being given purely on a temporary basis and is subject to the report of State Level Inspection and Vigilance Committee fulfilling of all the prerequisite conditions under A.P. Educational Act, 1982 and it later found that the school has not fulfilled any prerequisites as stipulated, the permission now being given is liable to be withdrawn at once.


